

## Learning Centre training - Schedule of fees

### Subsidised training courses:

The Queensland Centre for Mental Health Learning is funded to provide specified training (**subsidised** courses) for Queensland Health Mental Health Service Clinicians (Queensland Health Clinicians whose primary role is working with mental health issues). University students undertaking placement within a public mental health service are eligible for the subsidised places for training whilst on placement only.

Those who do not fall under this category are required to pay a nominal fee to participate, see table below for fee structure.

Subsidised training courses include: 10120NAT, QC2, QC4, QC8, QC9, QC12, QC13, QC14, QC19, QC24, QC25, QC26, QC28.

### Un-subsidised training courses:

For un-subsidised training, **ALL** participants are required to pay the corresponding fee for their place. See table below for fee structure.

Un-subsidised training courses include: QC3, QC23, QC27, QC29\*, QC31.
